



The Wyndham Green vacations focus on 24 of North America's greatest vacation spots. Recipients will pay a room tax deposit of \$75. Upon making a reservation, the room tax will be determined and the balance refunded prior to departure.

Airfare is not included with these vacation getaways. Each recipient is responsible for their own transportation to and from each destination.

Terms & Conditions of Wyndham Green Certificates:

1. Lodging: This Get Up & Go!® by Wyndham Certificate entitles the recipient to 3 nights of accommodations in a standard room in a hotel such as Days Inn, Howard Johnson, Comfort Inn or comparable as assigned. Accommodations are for two adults 21 years of age or older. No pets. This Certificate is for hotel accommodations only and does not include transportation, parking fees, airfare, room taxes (\$4 to \$25 per night), meals and any miscellaneous expenses.

2. Availability: Valid arrival days are Sundays, Mondays, Tuesdays. Accommodations are assigned based on availability. Myrtle Beach, Seaside and Wisconsin Dells are not available during June, July and August.

3. Activation (Step 1): You must activate the Certificate and select your destination within 45 days of receipt. There is no cost to activate. Upon activation, you will be mailed your Activation Letter including the toll-free telephone number to reserve your arrival date (please allow for mail time).

4. Travel Window: Your activated Certificate will be valid for 12 months from the Activation Date printed on your Activation Letter or no later than the expiration date listed here on your certificate, whichever comes sooner. Travel must be completed before the expiration date printed on your Activation Letter.

5. Reservation (Step 2): All reservations require at least 60 days advance notice. Please call the toll-free number

in your Activation Letter to make your reservation. At the time of reservation, a room tax deposit will be collected payable only by credit card. Any unused portion of the room tax deposit will be refunded prior to your arrival date. You will receive a Reservation Letter with your selected destination and arrival date. Date and name changes will not be permitted.

6. Confirmation (Step 3): Your personal travel representative will contact you by phone to finalize details of your reservation before accommodations are purchased.

7. Cancellation: Until your accommodations are purchased, you may cancel your reservation and receive a refund of your room tax deposit.

8. Travel Documents: You will receive your hotel voucher 10 to 14 days prior to your arrival date. You will need a valid photo ID and hotel voucher to check in to your hotel. Hotels may require a credit card imprint to cover incidental charges.

9. Usage Limitations: You may not use this Certificate in conjunction with any other travel offer. Only one Certificate per household may be used within a 12 month period. This Certificate is intended for promotional use only and cannot be sold to the recipient. It is nontransferable and may only be used by the original recipient. This Certificate is not intended for conventions or group travel. Lost or stolen Certificates will not be replaced.

10. Fulfillment: This Certificate is administered and fulfilled by Casablanca Travel Services on behalf of Wyndham Vacation Resorts. Casablanca Travel Services will arrange hotel accommodations acting only as an agent for hotels. Casablanca Travel Services will process the room tax deposits. Neither Wyndham Vacation Resorts nor Casablanca Travel Services assumes any responsibility for loss, delay, accident, injury or damage to persons, property or any liability whatsoever arising from or in conjunction with services provided.

11. Retail Value: The approximate retail value of the accommodations is \$177 to \$690 depending on location, hotel and travel dates.
